NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India. The Governor of Sikkim hereby makes the following rules further to amend the Sikkim Subordinate Accounts Services Rules 1984, namely:-

Short title and Commencement.

- 1. (1) These rules may be called the Sikkim Subordinate Accounts Service (Amendment) Rules, 2017.
 - (2) They shall come into force at once.
- 2. Amendment of Rule 2 in the Sikkim Subordinate Accounts Service Rules, 1984 (hereinafter referred to as the "said rules", in rule 2,-
 - (1) In clause (b), for the words "Finance Department", the words "Finance, Revenue and Expenditure Department" shall be substituted;
 - (2). In clause (g) for the words "Finance Department", the words "Finance, Revenue and Expenditure Department" shall be substituted.
- 3. Amendment of rule 4 in the said rules, in rule 4, after the words:-
 - (1) In sub rule (1), after the words 'scale of pay' and before the words 'shall be such' the words 'and grade pay' shall be inserted.
 - (2) Sub-rules (2) and (3) shall be omitted;
 - (3) Sub-rule (4) shall be re-numbered as sub-rule (2).
- 4. Amendment of rule 7, in the said rule, rule 7.-

- (1) In sub rule (1) for the word and figure "and III" appearing at the end, the words "and other Government instructions issued from time to time on the subject" shall be substituted.
- (2) for sub rule (2) and the entries relating thereto, the following shall be substituted, namely:-
 - "(2) Recruitments to duty posts in grade IV shall be made by the controlling authority on the recommendation of Sikkim Public Service Commission or other authorities as may be notified by the Government from time to time as and when vacancy arises. The selection of persons for appointment shall be made by the Departmental Promotion Committee constituted in accordance with the instructions issued by the Government from time to time".
- (3) In sub-rule (3), after the words 'Controlling Authority' the following shall be inserted namely: 'on the recommendation of Sikkim Public Service Commission or other authorities as may be notified by the Government from time to time'.
- (4) For sub rule (5) and entries relating thereto, the following shall be substituted, namely:- "(5). The selection of persons for appointment on promotion in their respective grade shall be made by the controlling authority on the basis of recommendations of Sikkim Public Service Commission and the Departmental Promotion Committee constituted by the controlling authority. The selection shall be based on the result of Limited Departmental Competitive Examinations, evaluation of service records, ACRs and other prerequisites prescribed by the government from time to time. The number of posts, syllabus, date of examinations and other criteria for the Limited Departmental Promotion Examination shall be notified by the controlling authority'.
- 5. In the said rules, in Schedule 1, column 3 and the entries relating thereto shall be omitted.
- 6. In the said rules, for the existing "Schedule II" the following "Schedule II", shall be substituted, namely:-
