**OFFICE MEMORANDUM**

**Sub:- Recommendation of Fourth Pay Commission –Decision of Govt. relating to Grant of Dearness Allowance /Dearness Relief to State Govt. Employees and State Govt. Pensioners-Revised rates effective from 01.01.2006, 01.07.2006, 01.01.2007,01.07.2007, 01.01.2008, 01.07.2008 and 01.01.2009.**

The undersigned is directed to say that consequent upon the decision taken by the Govt. on the recommendation of the Fourth State Pay Commission relating to Dearness Allowance /Dearness Relief the Governor is pleased to decide that the Dearness Allowance/Dearness Relief admissible to all categories of State Govt. Employees and State Govt. Pensioners shall be admissible from the dates mentioned below at the following rates:-

<b>Date from which payable</b>	<b>Rate of Dearness Allowance/ Dearness Relief</b>
From 01.01.2006	No Dearness Allowance/Dearness Relief
From 01.07.2006	2% of Basic Pay / Pension
From 01.01.2007	6% of Basic Pay / Pension
From 01.07.2007	9% of Basic Pay / Pension
From 01.01.2008	12% of Basic Pay / Pension
From 01.07.2008	16% of Basic Pay / Pension
From 01.01.2009	22% of Basic Pay / Pension

The Payment of Dearness Allowance/Dearness Relief under these orders from the date indicated above shall be made after adjusting the installment of Dearness Allowance/ Dearness Relief already sanctioned and paid to a State Govt. Employees/ Pensioners with effect from 01.01.2006 vide circular No. 04/Fin/Bud dated. 10.05.2006, 01.07.2006 vide circular No. 18/Fin/Bud dated 01.11.2006, 01.01.2007 vide circular No. 01/Bud/Fin dated 01/05/2007, 01/07/2007 vide circular No. 12/Bud/Fin dated 18/09/2007, 01.01.2008 vide circular No. 24/Fin/Adm. dated 26/03/2008, 01/07/2008 vide circular No. 10/Fin/Adm dated 21/02/2009, 01/01/2009 vide circular No.03/Fin/Adm dated 11/06/2009.

The Dearness Allowance at the above rates will also be admissible to the employees appointed on Contract Basis and Work-Charged Establishment drawing regular scales of pay.

The payment on account of Dearness Allowance/Relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.
